### All Change at the Top

Gordon James is certainly one of the most dedicated and inspiring environmentalists I have met.

As many will know he is retiring as director of FoE



Cymru in September. Gordon has been involved with Foe since its 40 beginning years ago. His interest in the environment began with his upbringing in Pembrokeshire. As a child he spent a lot of time outdoors surrounded bv

wildlife and nature, living what, by today's standard, was a simple life enjoying good local food against the back drop of the post war years. Then 60's influences, such as Rachel Carson's book Silent Spring, about the effect on wildlife of agricultural pesticides, the impact of the Vietnam War with its huge human suffering and environmental degradation and the nuclear question, combined with this upbringing to draw him towards the early green movement.

In 1972 he first got involved with FoE starting our own local group in 1987. He worked for FoE Cymru as Head of Campaigns and Development becoming the director in 1995. In 2000 he left FoE to work as Director of the Pembrokeshire Energy Agency which had been set up by the West Wales Eco Centre, returning to FoE in 2007. His measured well researched and informed opinions expressed at meetings and through both the Welsh and English media have contributed to many successful campaigns, including orimulsion and GM of which he is particularly proud. He has earned the respect of politicians and helped to ensure that Friends of the Earth Cymru is listened to.

The new director is Gareth Clubb. He comes to FoE

from the Snowdonia Society. He went to Bangor University and then studied marine biology in Maine going on to complete an MSc in marine resource development at Heriot-Watt University in 2000. He has worked on the environment sustainability and since then, both as



a senior research officer for the National Assembly of Wales and as a policy advisor for the Environment Agency Wales. Gareth is looking forward to the job immensely. "There is no more important role in Wales than that undertaken by Friends of the Earth Cymru," he says. "They've been a beacon of light over the past 25 years."

We are very glad to say that Gordon intends to continue campaigning with FoE Pembrokeshire but is looking forward to giving up the regular commute to Cardiff.

### Pembroke Power Station 'unlawful'

In June, the Environment Agency announced that it was 'minded to' grant an environmental permit for the new gas-fired power station at Pembroke to operate but that it was allowing a period of four weeks for public consultation. Friends of the Earth Cymru has submitted a very critical response, written by environmental barrister Peter Roderick, calling the Agency's document "inadequate, incoherent and unlawful".

We have argued from the outset that the waste heat from the power station should be used productively to convert the imported Liquified Natural Gas (LNG) back into gas. This is what is happening at the new gas-fired power station at the Isle of Grain in Kent, cutting carbon dioxide emissions by 350,000 tonnes a year.

At Pembroke, the intention is to dump this waste heat – which is equivalent to 40 per cent of Wales' electricity demand – into the Milford Haven waterway. According to Countryside Council of Wales (CCW) documents, this water cooling system would result in the entrainment of up to 1.3 billion juvenile fish and almost three million crustaceans each year.

The Milford Haven waterway is, as part of the Pembrokeshire Marine Special Area of Conservation, one of Europe's most valuable marine environments. This is why the Welsh Government's environmental experts at the CCW have strongly opposed this application. If the Environment Agency had listened to these objections we would not be in this problematic situation today.

Industry can exist alongside Pembrokeshire's magnificent natural environment – but we must use the best technology and the highest standards.

Friends of the Earth Cymru has asked Wales' Environment Minister to call-in the application and has also sent the European Commission, which is continuing to investigate it, this latest information. We await their response.

# WELSH GOVERNMENT HALTS NEW PEMBROKE POWER STATION

The Welsh Government has told the Environment Agency that it mustn't give permission to a controversial water cooling system at the new Pembrokeshire power station until a review into its impact on a fragile and highly protected marine wildlife site has been completed.

In a letter to the Environment Agency, the Government has criticised the report that was expected to give the damaging plant the go-ahead, saying there were "gaps in the analysis and logic to support the conclusions reached".

#### Narberth Area Renewable Energy Group – NAREG

There have now been several meetings of this group. Its aim is to look at ways of promoting and developing renewable energy in Narberth to benefit the community and the environment. Group activities could range from awareness raising, encouraging energy users to change to green energy suppliers or tariffs, to community based renewable energy projects and maybe our own wind turbine.

NAREG is a small group of busy people who are determined that they do not want to be another talking shop. Planed has done a fantastic job providing information and at the present time we do not have the resources to tackle a project as large as a wind turbine, so the group is hoping to carry forward 2 renewable energy projects for Bloomfield and the Queens Hall, at the same time as encouraging the Rugby Club to look at the potential for renewable energy for themselves.

The aims of these projects are to provide solar hot water for Bloomfields, and electricity through photovoltaics for the Queens Hall and Bloomfields. These projects will not only benefit the environment by lowering our community carbon foot print they will also reduce costs and provide a source of income through the feed in tariffs. Both of these projects have already been proposed so all we really need is the money!

The cost of the 2 projects is around £50,000. The group is considering a 'buy a panel scheme' similar to 'buy a brick'. We will also explore mounting an appeal to charitable trusts.


It feels good to get involved in a real project and by doing so we hope to raise awareness throughout the community.
