Food Chain Campaign

Factory farming of meat and dairy is helping push the planet to the brink of runaway climate change as forests are being cleared to grow soya for animal feed.

Farmers need support to move away from imported feeds to home grown diets.

Many of you will have sent postcards to your MP to support a new law to measure and reduce the environmental impact of the UK's meat and dairy consumption. The best opportunity to take a step towards that goal lies with the private members ballot that will follow soon after the general election.

Our campaign has helped an issue that almost no MPs knew about to become a topic that almost everyone in Westminster is aware of.

Local farmers Gerald Miles and Tom Latter are working on a Community Support Agriculture (CSA) scheme in the St David's area which offers an innovative business approach where a food or farm enterprise has members who own 'shares' in the harvest and therefore also share in the risk.CSA enterprises could consist of a community making an agreement in advance to purchase a particular crop from a producer, the community members making regular input of labour.

New Heat and Power Plant Unveiled

A new heat and power plant (CHP) which will supply the energy needs of one of Milford Haven's terminals was unveiled at the beginning of February 2010. It will supply up to 49MW of electricity and 73MW heat to the Drago LNG terminal as other companies on the site at Waterston. We have been campaigning for CHP for many years.

Development Plan

The council is now proposing that the Deposit plan will be considered by the authority's Cabinet in March and April 2010, and subsequently by Full Council in May. Subject to agreement at these stages, the Deposit Local Development Plan will then be published for public consultation purposes during the summer. Statutory consultation period at this stage is only 6 weeks.

Great News for Cwm Arian Renewable Energy Project – Hermon, Glogue and Llanfyrnach.

The project known as Cwm Arian Renewable Energy (CARE) has been successful in clinching one of 22 grant awards from across Britain. In total the grant known as Low Carbon Communities Challenge was offering £10,000,000 to be split between communities with exciting ideas for lowering carbon footprints and stimulating social enterprises from revenues generated from community renewables. The scheme is administered by the UK governments Department for the Environment and Climate Change – see details on www.decc.gov.uk_

Within the area of Hermon, Glogue and Llanfyrnach there is now an opportunity to distribute energy monitoring display units for free to each household (normally ± 25)

Then to help householders, farmers and business people to look at opportunities of lowering carbon emissions. There will be opportunities and help for farmers and business people to look at installing renewable energy equipment such as hydro turbines, solar systems or wind energy.

The main idea is to have 2 wind turbines that would be owned by the community and would give them an annual profit of £200,000 from energy sold to the national grid. The money would stay in the communitybe used to support community groups and also start looking at social enterprise businesses that would be owned by the community. To create jobs and opportunities for local people.

One future project idea would be to purchase land and to put up community owned business units for local young people to pilot new businesses and also the community to start up social enterprises & cooperatives owned by the community. Also to purchase land for a Community Land Trust to build affordable houses that the community would own.

There will shortly be a public meeting announcement to encourage individuals to get involved in this exciting project. The initial plan is to focus on the catchment area of Hermon, Glogue and Llanfyrnach but during the next few years there is an intention to extend the development to neighbouring communities.

Friends of the Earth threatens legal challenge to government's nuclear plans

FoE has threatened to launch a legal challenge against the government over its "fundamentally flawed" plans to approve hundreds of new nuclear reactors, power plants, wind farms, electricity pylons and pipelines.

The group has written to energy secretary Ed Miliband warning him that government planning statements issued in November breach environmental regulations and had not followed proper consultation. Friends of the Earth said it was also supported by conservation groups, the WWF and RSPB. The energy industry and ministers have been braced for a legal challenge for months, particularly over plans to build as many as 10 new nuclear reactors.

Friends of the Earth said it believed the statements, which new planning commission the IPC will use to block or approve applications, would result in Britain "locking-in" to a highcarbon energy infrastructure. It said the IPC should have to directly take into account the carbon emissions resulting from individual applications.

Friends of the Earth's executive director, Andy Atkins, said: "The government's draft national planning statements on energy are fundamentally flawed. The consultation was insufficient, the alternatives were inadequately explored, and the policies are poorly justified. And because they fail to assess the carbon impact that the proposed development will have they threaten to undermine UK carbon budgets."

PROTECTING WELSH SEAS

Pembrokeshire FOE sent a letter welcoming the Welsh Assembly Government's consultation 'Protecting Welsh Seas: a strategy for Marine Protected Areas'.

The principle of establishing marine conservation zones (MCZ) is very important; experience here in Pembrokeshire, so beautifully illustrated to us by Phil Newman of Skomer Marine Nature Reserve at our AGM, and throughout the world has shown the great value of protected areas to the biodiversity of the marine environment. An environment which suffers from being "out of sight, out of mind", and which, all too often, is seen purely as a resource for man to exploit. At a time of unprecedented threats from pollution, dredging, shipping, oil and gas drilling, and most importantly exploitation by over fishing this has never been more urgent.

The most sensitive areas such as the Skomer Marine Reserve should become no take zones set within wider areas where fishing is controlled and harmful activities such as the dumping of dredging spoil and scallop dredging is prevented.

However we are also concerned that the study of the marine reserve at Skomer should continue into the future. This work and the experience the team has gained over the last 20 years has contributed enormously to this debate; and with the background of the changes likely to occur due to climate change, longitudinal and prospective research of this kind is invaluable. This experience has shown is there is no substitute for people on the spot to encourage and where necessary enforce protection and to engage with the users of the sea.

We understand that it is not the intention of the draft document to weaken the protection around Skomer, but without adequate leadership and resources this may be an unintended consequence. In the final document we would like to see one body with overall responsibility and where other bodies such as local authorities are involved their role and responsibilities should be clearly defined. We are concerned that the SAC-approach which places "a duty on all public authorities ... to undertake their functions in a way that will further ... the achievement of site conservation objectives" is not appropriate. There is a considerable danger that the cracks between the different bodies and their areas of responsibility will be exploited by those who are pursuing profit with no regard for conservation.

The success of Skomer has been due in large part to the clear leadership of CCW and their team. Clearly this model cannot be resourced across all the MCZ but we urged that the final document looks at this model for selected areas (ie High Priority MCZ's) and clarifies the responsibility and mechanisms for enforcement in the wider areas.

Marinet , FOE Marine Network -representative needed

With the passage of the Marine and Coastal Access Act into law, the government is now in the process of deciding where marine conservation zones should be established in order to protect our seas.

In the case of Wales, the identification of marine conservation zones (MCZs) in Welsh territorial waters (out to 12 nautical miles) is a devolved matter for the Welsh Assembly, and a process for the identification of Welsh MCZs is currently being set up.

MARINET would like to take part in this process to ensure that the MCZs are identified on a sound basis, and that various economic interests do not dominate and distort the process. It is most important that a comprehensive and ecologically coherent network of MCZs is established because, without this, there is little chance that our seas will be restored to health.

MARINET is therefore looking for someone from within the Welsh FOE Local Groups to represent us in the Welsh Assembly process of identifying these MCZs. The absence of prior experience is no a difficulty, as we will give you training in the issues should you require this. We will also pay your out of pocket expenses involved in this project.

Rural Affairs Minister Elin Jones has announced new regulations to restrict scallop fishing off the Welsh Coast which came into force on St Davids Day.

"The new regulations will protect scallop stocks and safeguard important marine species and habitats through a range of technical and spatial restrictions"

This will help maintain a viable and sustainable scallop industry for fishermen operating in Welsh waters.



The Pembrokeshire Wave
